

Ever Expanding Knowledge about... Violence Against Women & Men Who Perpetrate the Violence - Three Studies ---- #1. Violence Against Wives

1974--: RESEARCH STUDY – [findings reported in 'VIOLENCE AGAINST WIVES']

Interview 109 'battered' women in 1st refuges for 'battered women' in Scotland

Examine 34,724* police records (all police cases for 1 year) Edinburgh & one district in Glasgow)

Data: How much violence? How much violence against 'wives'?

Nature of the Violence & Injuries?, Responses to women? Responses to men?

Of 34,724 police cases,

--- 3,020 involved ANY FORM OF VIOLENCE [ie. all violence],

..... of 3,020 cases involving any form of violence,

......759 cases involved violence against a woman partner

..This Represents 25%* Of All Cases Of Violence Dealt With By Police

* Similar Findings have been found elsewhere






Types of Violence


Types of Violence (prevalance)

(reports of men and women compared)



Injuries (prevalence) (reports of men and women compared)





Overview – What do these two studies tell us about men who use violence against their woman partner?

Both interviews and official records provide valuable evidence

- -Interviews with women who are abused provide detailed accounts of the nature and extent of men's violence & controlling behaviours
- -Men's violence is purposeful, intentional & functional, as well as serious & consequential.
- -Men & women give different accounts of the same violent incidents
- -Men's accounts of their violence are often sparse and exculpatory
- -Men's violence is usually proceeded by disputes and intimidation
- -Men's violence & aggression demonstrates that they are 'in charge'
- -Men's violence illustrates their sense of entitlement

Overall, this behavior constitutes a 'constellation of violence' that includes physical and sexual violence, as well as controlling & coercive behavior

What Did the Men Say About Their Violence to Their Woman Partner?

Intimate Partner Abusers - Accounts

Accounts – men enter the narrative at points that blame the woman...

- Selective forgetting/remembering circumstances, events, violence
- Deny , 'nothing happened'
- Rationalize, 'I had just lost my job', 'I was drunk', ...
- Discount/minimize, 'it wasn't very bad; it wasn't that bad, others have done worse'

Man blames:

- -loss of control, 'I just lost it', but men had clear objectives: 'to freighten/to punish, ...
- Blames the woman, 'If she hadn't; If she had'
- -Alcohol/drugs, 'It was the drink'; I was high'
- -Contradiction: 'I didn't do it', ... but seeks forgiveness for doing it



Objectives

- all types of murder
- pathways to murder
- contexts, situations, circumstances & murder event
- relationships between perpetrators & victims
- perpetrators lifecourse: child adulthood murder
- 3 Sources of Data: (quantitative & qualitative)
- -Homicide Index [official database for UK]
- -866 Casefiles of murderers: (786 men, 80 women)
 - •sample: all murderers currently serving life in prison:
 - •- England & Wales (3,000 men, 115 women)
 - Scotland (500 men, 10 women)
- -200 Interviews with murderers in prison:
- (180 men, 20 women)







Context of IPMurder & Murder Event

<u> Intimate Partner Murder (IPM)</u>

Context of IPMurder:

- Relationship, Situation, Context
- Prolonged conflict
- Possessiveness, jealousy, control
- Previous violence (physical, sexual)
- Tenuous relationship- dating, cohabitating
- Separation/ Attempts to leave
- Divorce / New Male Partner

Changing the Project:

...(from trying to 'keep' her to deciding to 'destroy' her

Murder Event (IPM):

- location: at home
- Only one perpetrator
- Ongoing dispute
- Confrontation
- Some men (perpetrators) were drinking, a few men were drunk


Method of killing woman partner:

- Choke/strangle, Beat, ...
- Instruments/household knives

Collateral Murders: other victims children, protectors, new male partners



Brief Overview

(Lifecourse) - Childhood & Adulthood -

Men Who Murder Women Intimate Partners

Male Perpetrators:

Childhood (over 50%):....

School problems, with learning&/or discipline

•Male Perpetrators:

•Adulthood (over 50%):

- •- Unemployed
- •- Previous conviction
- •- Violent in a previous intimate relationship
- •- Had problems with women
- •- If had a previous conviction for violence, the victim was a woman

Dobash & Dobash

IPMurderers Men with Previous Convictions & Men with NO Previous Convictions

IPM with previous convictions (75%, n=79) 'the expected'

-IPM with NO previous convictions (25%, n=25) 'out of the blue'

Similarities

-Intimate Partner Murderers — Men WITH & WITHOUT Previous Convictions

Circumstances & Situations

- Ongoing dispute (often long duration)
- Previous Violence to victim (physical & sometimes sexual)
- Jealousy/Possessiveness
- Separation threats of separation attempts to separate

Orientations

- Problems with women
- Lack of Remorse [for murdeer]
- Lack of Empathy [with his victim]
- Assessed as Dangerous

What Did Men Say About Murdering Their Woman Partner?

'What Were They Thinking' Problems with Women in Intimate Relationships

Problems with Women

Throughout his adult life, he has displayed evidence of a difficulty in maintaining stable relationships with women.

He now recognizes that he needs to look at his attitude to women. There are many issues in his treatment of his wife prior to her death that need addressing. She was a tiny, frail young woman, who was oppressed.

Denial of Previous violence to intimate partners

'He has a history of relationship problems with a propensity to use violence against females.

'He says he only ever hit is wife once before - denies a long standing history of domestic violence'

If I remember, I only hit her twice'

'What Were They Thinking'

Denial - Denial - Denial

Deny the murder

'I couldn't believe it.... I've only ever seen one document where it actually said 'deceased'.

'He continues to claim death was an accident – she fell on his knife'

'I never thought my wife had died. I thought she was in a deep sleep.'

Acknowledge Murder but Deny Responsibility for Murder

'He tends to present his behavior as a mystery which he can't solve, and isn't responsible for.'

'It is convenient for him to see himself as mentally ill.'

He sees it as a domestic offense and the [sentence] as too high.

'The police said this was premeditated which I deny. It was an accident which happened while I was drunk'.

'What Were They Thinking'

Orientations to Murder – No Empathy, No Remorse

Lack of Empathy & Remorse

'He is extremely dangerous, a complete absence of remorse, compassion or pity for his victim'

'I felt they [the victims] deserved to be taught a lesson.'

His almost total omission of thoughts on his feelings for his wife and daughter may reflect the degree of regard he had or has for them [near zero].

'I could find no evidence of spontaneous empathy or appropriate remorse apart from the effect on himself.

'He showed very little emotions while recounting the details of his offense and there was little to indicate any remorse'.

'What Were They Thinking'

Orientations to the Murder – Blame the Victim

Blame the Victim

'He has no real insight into the circumstances leading up to the offence. He claims she was a very bossy woman'.

Blame the Victim

..He says he just 'snapped'

He insists this stemmed out of severe provocation from his wife... He says she had gone on and on at him, he 'snapped' and reached for a hammer. He viewed her as a 'nagging, ungrateful wife' and himself as a 'bullied husband'.

'What Were They Thinking' Possessiveness & Jealousy Separation & Changing the Project

Using violence to try to keep her

'The relationship deteriorated & she wished to terminate it. In an effort to dissuade her, he carried out a prolonged and vicious attack'.

'Changing The Project'

'She made various attempts to break off the relationship. He had made up his mind what he was going to do with the woman who no longer wanted his attention – she was going to die'.

- What were they thinking -

Problematic:

Orientations to women,

Relationships with women,

Problems with alcohol

Previous Violence & Murder:

- Denies, doesn't remember, not his fault, refuses to talk.....
- Offers Inauthentic apology &/or no empathy, no remorse
- Blames victim
- Self pity
- Egocentric: effect of [murder/conviction/prison] on HIS LIFE


- Prolonged conflict


